 - i. Reviewed timeline and upcoming open positions. Nominations opening 10.29
 - 1. We need special population, UCollege, one department
 - a. What is a special population? Athletics, honors, trio, into, etc. will include that information when it is sent out.
 - Should we consider HOPE, MASAI, STEM, Soar, etc. (really increases UC representation)? Someone from student success (community of practice or student success positions) is the important clarification.
 - Looking into bylaws, the special populations descriptors need updated because "into" is not a program anymore. Needs updated/voted on.
 - i. Janet: What is the purpose of special pops as a distinct category? Because we've done it that way forever.
 - ii. Is it something we still need? Advising has certainly evolved since this was created. Thinking about this might help us define what a special population is if we have a rationale as to why/what.
 - iii. How do we make this document as accurate and general but still capturing everyone – make it to something we don't have to update often? Do we say 5 elected department/honors and 3 elected members from UC advising unit – it includes honors and special

- populations. We don't necessarily have to specify special populations.
- iv. Special populations does include representations of students and advising practices that are distinct from "typical" /mainstream advising. Some of the special represent our most diverse students.
- v. Does this give "unfair" advantage to advisor who might fall under both categories? In terms of election standpoint. Could be something to consider if we are viewing special pops.
- vi. An idea--3 department/honors, 3 UC: with 1 special pop in UC. Do not need 2 student reps.
- vii. We could ask the advising community their thoughts on the matter.
- viii. Thoughts for future election term.
