yearOne Overview (Danielle Lindsey)

Danielle Lindsey provided an overview of the yearOne initiative as well as provided a handout describing the yearOne mission, goals, focus, and committee members. Danielle Lindsey and Danielle Miller-Schuster are the primary contact people for yearOne. The initiative is to increase the visibility of first year services that the university provides for students. The goal wasn't to recreate services but rather to create a common identifier for students and family members to recognize and associate with the first year at ISU and also increase partnerships across campus to enhance first year services. YearOne marketing will be distributed to new transfer students as well as new freshmen. YearOne marketing will be distributed at Freshmen information nights, Prview, and all info that is distributed to first year students. The Assessment Office will be working closely with the YearOne committee. There is currently a placeholder website. The yearOne website will include links to services that are currently available. The goal is not to be redundant. The YearOne committee will have an annual report.

YearOne is an overarching umbrella for the services that already exist. The committee is not there to radically change things. Units are responsible to still run their programs. YearOne is there as a support.

The technology piece has not yet been decided. They are currently working with a vendor who is demonstrating some options but nothing has been decided on. They are considering web platforms that have user generated content. The committee is trying to take a look at what we need for our university.

The committee is also assisting in a pilot of the common reading program with other department/schools in CAS. Ron Gifford demonstrated an excellent example of this common reading with history majors during Passages 2008.

Suggestions from AAAC included:

Add an Academic Advisor as a committee member, perhaps from a department.

Consider how graduate students fit into this.

YearOne information could also be incorporated in the annual newsletter for advising.
